

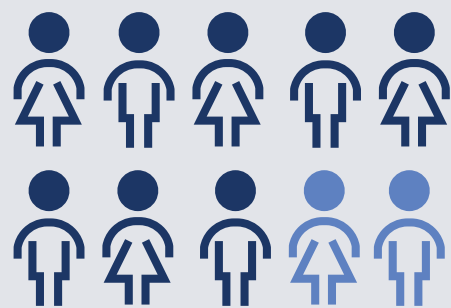


Payment Protection
