Be aware of those that contact you and ask for your identifying information, like account numbers, PINs, CVV security codes, social security numbers, DOB; most likely this has the potential of being a scam.

Tips to Avoid Fraud

Pay attention to even seemingly harmless requests. A common play scammers use is emailing you a link to do something like change your account password. The link, in reality, will download malware or spyware. Do not open any links or documents that you're not expecting to receive.

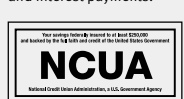

TopLine Credit Union Foundation Scholarships!

TopLine Credit Union Foundation **will be awarding \$14,000 in scholarship money to TopLine members who are continuing their education.** The scholarship awards include fourteen \$1,000 scholarships.

Any individual planning to pursue or continue post-secondary education by attending a college or university, graduate school, or a 2 to 4 year community, vocational or technical college in the fall of 2021 is eligible. All eligible schools must be accredited by the U.S. Department of Education.

The application deadline is August 31, 2021.

Scholarship recipients will be selected and notified by October 15, 2021.

Those interested need to complete a one-page application form and submit an essay (500 words or less) that answers the question: *"Describe a time in your life where you experienced adversity and overcame obstacles either through your education, social or family life? How do you plan to use what you learned to achieve your future goals?"*
