

# TopLine Federal Credit Union Home Equity – Twins Tickets Prize Drawing (“Sweepstakes”) OFFICIAL RULES

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. VOID WHERE PROHIBITED BY LAW.**

**1. Eligibility:** Sweepstakes is open to all U.S. Residents. Must be 18 years of age or older to enter. TopLine Federal Credit Union employees, subsidiaries, officers and members of the Board of Directors, Supervisory Committee and their immediate family/household members are not eligible. Participant may not win more than one prize.

**2. Consumer Disclosure:** Odds of winning are based upon the number of entries.

**3. How to Enter:** The TopLine Federal Credit Union Home Equity – Twins Tickets Prize Drawing (“Sweepstakes”) begins at 9:00a.m. April 18, 2016 and ends at 6:00 p.m. (CT) on June 30, 2016 (“Sweepstakes Period”). Participants may enter by writing their member number, name, address, phone number and email address on the entry form with signature. One entry per person.

**4. Prizes:** Two (2) Twins Tickets, approximate value of \$191.00.

**5. Drawings and Notification:** For the prize drawings, the potential winner will be randomly selected in drawing held on July 8, 2016. The winner will be notified in person, by phone at the phone number on record with TopLine and/or by e-mail. Winner has until July 30, 2016 at 12:00p.m. to pick up the prize at TopLine Federal Credit Union, Maple Grove at 9353 Jefferson Hwy, Maple Grove MN 55369. Should the winner forfeit the prize by not picking it up by the deadline or decline the prize, alternate winner may be selected from the remaining eligible entries, at Sponsor’s sole discretion. Winner’s acceptance of a prize constitutes permission for the Sponsor to use winner’s name and address (city and state only) information, for advertising/publicity purposes and in all forms of media (including posting on website), in perpetuity, without further notice to or compensation in connection with said Sweepstakes or the prize awarded.
