

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER

OPEN TO LEGAL RESIDENTS OF THE UNITED STATES (EXCLUDING THE U.S. VIRGIN ISLANDS, AND OTHER COMMONWEALTHS, TERRITORIES AND POSSESSIONS), 18 YEARS OR OLDER.

1. By entering this CONTEST (the "Contest") and accepting the terms herein, you agree to be bound by the following rules ("Official Rules"), which constitute a binding agreement between you and TOPLINE FINANCIAL CREDIT UNION. These Official Rules apply only to this Contest and not to any other contest sponsored by TOPLINE FINANCIAL CREDIT UNION.

Step 1: Visit <https://www.toplinecu.com/> for contest rules and restrictions.

Step 2: INSTAGRAM - Enter on TopLine's Instagram for the specified time frame of desired giveaway item. Contestants can enter once during each prize period (date). Submissions are accepted Dec. 4 through Dec. 15.

OR

Include your name, email address and phone number in the email message. Entries using this method are valid for the prizes awarded during that time period.
